Your registration fee will go towards your August tuition and is **non-refundable**.

Annual Tuition & Deposit

Regular Tuition: \$2,700.00/year (\$270.00/month)

Reduced Lunch Qualification*: \$2,200.00/year (\$220.00/month)

Free Lunch Qualification*: \$1,700.00 (\$170.00/month)

A non-refundable deposit of \$270.00 is due at the time of registration and will be applied as the first month of tuition.**

The remaining tuition is due in nine equal installments on the fifth of every month in September through May. Tuition may be prorated monthly for students enrolled in the program for only a portion of the school year. For example, a student entering the program the last week of January will be charged for the full month of January but not for months prior to January.

Late Fees

If payment is not made in full by the 10th of each month the school will add a \$20.00 late fee to the total amount due that month, including in instances of returned checks.

Failure to Pay

If payment is not received by the end of the month the student will not be allowed to return to the full day program until outstanding fees are made current.

The District shall have no right to deny the student free half day kindergarten. Exclusion from the full day program for failure to pay fees does not release or diminish the obligation of the parent or guardian to pay outstanding tuition and late fees.

Billing

Secretaries shall bill one ninth of the annual tuition on the first of each month in September through May.

*A letter from Nutritional Services must be provided by the parent/guardian to the school office to demonstrate free/reduced qualification. All students will be assessed the regular rate until proof of qualification is delivered to the school by the parent/guardian.
